Dear Sir or Madam:

This letter will serve as notice under the Worker Adjustment Retraining and Notification (WARN) Act that Select Medical Corporation (“Company”) intends to permanently layoff certain employees at the Company’s Select Specialty Hospital-Lincoln, Inc. hospital (“SSH-Lincoln”), located at 2300 South 16th Street, 7th Floor, Lincoln, NE 68502. This decision will result in the permanent closure of SSH-Lincoln in Lincoln, Nebraska. We hope to accomplish this closing with the least possible disruption to the lives of our employees and the community.

SSH-Lincoln will close on or about December 10, 2021 or within fourteen days of this scheduled layoff date. As set forth on the attached listing of terminated job positions, it is expected that 93 employees will be affected by the layoff. There will be no bumping rights. None of the employees are represented by a union.
