SUBJECT

June 1, 2020 deadline for notification of the outcomes of one-stop delivery system assessments and one-stop center certifications

PURPOSE

To provide information to Chief Elected Officials, local boards, and local area administrative entities regarding a possible extension of the June 1, 2020 deadline for notification of the outcomes of one-stop delivery system assessments and one-stop center certifications



ACTION

Effective April 28, 2020, the June 1, 2020 deadline for notification of the outcomes of one-stop delivery system assessments and one-stop center certifications *may* be extended until August 1, 2020 if a local board provides NDOL with sufficient written justification for an extension as described below.

NOTICE

As required under NDOL's current policy on one-stop delivery system assessments and one-stop center certifications,¹ local boards must notify NDOL of the outcomes of the assessments and certifications by June 1, 2020. Social distancing requirements established under Directed Health Measures issued by Governor Ricketts may affect the ability of local boards to complete the assessments and certifications by June 1. For that reason, NDOL may extend the June 1 deadline until August 1, 2020 if a local board provides NDOL with sufficient written justification for an extension.

To be eligible for an extension, a written request must be submitted by the local board to the WIOA Policy mailbox at ndo!.wioa_policy@nebraska.gov no later than May 8, 2020. The request must include:

- a clear description of the local board's established methods for assessment of the local one-stop delivery system and one-stop center(s) and certification of the one-stop center(s);
- copies of all forms used for assessment and certification;
- a description of the actions the local board has taken to conduct and complete the assessment and certification(s), as of the date of the request;
- an explanation of the circumstances that will prevent the local board from meeting the June 1 notification deadline:
- a description of the actions the local board will take, if an extension is granted, to ensure completion of the assessment and certification(s) and submission of the outcomes notification to NDOL by August 1.

NDOL will make a written determination on the request by May 15, 2020. If an extension is granted, all other requirements established under the policy must still be met. If an extension is not granted, the local board must ensure that the assessment and certification(s) are completed and notification of the outcomes of the assessment and certification(s) is submitted by June 1 as required in the policy.
