# INFRASTRUCTURE FUNDING AGREEMENT Between THE GREATER NEBRASKA WORKFORCE DEVELOPMENT BOARD, THE GREATER NEBRASKA CHIEF ELECTED OFFICIALS BOARD, and PINE RIDGE JOB CORPS Job Corps (38 USC Chapter 41) Services

THIS INFRASTRUCTURE FUNDING AGREEMENT is entered into between the Greater Nebraska Workforce Development Board (GNWDB), the Greater Nebraska Chief Elected Officials Board (GNCEOB), and the Pine Ridge Job Corps (PARTNER), and is incorporated into and made a part of the Memorandum of Understanding between GNWDB, GNCEOB, and PARTNER, entered into in June and July of 2017, in accordance with the Workforce Innovation and Opportunity Act (WIOA).

### I - PARTNER Cost Allocation for Infrastructure Costs

- A. The cost allocation formula is based on customers served as reported by PARTNER in each district of the American Job Centers (AJCs) in Beatrice and Grand Island, Nebraska. The funds support the resource rooms in the AJCs, and comprise the costs of lease, facility maintenance, property and casualty insurance, cleaning services, utilities, and equipment. Calculation of infrastructure costs is set forth in Attachment-P-1 of this Attachment.
- B. Actual costs for the items set out in section (I) (A) will be reviewed by GNWDB and GNCEOB at the start of each program year, and contributions will be adjusted annually.
- C. The financial commitment of PARTNER shall be as follows: (1) \$8.94 for 21 months, from October 1, 2017 to June 30, 2019, for the Grand Island AJC; and (2) \$9.55 for 21 months, from October 1, 2017 to June 30, 2019, for the Beatrice AJC. The total for (1) and (2) equals \$18.49.
- D. The schedule for the PARTNER's payments shall be coordinated with the Administrative Entity, Nebraska Department of Labor, Office of Finance.
- E. PARTNER shall submit funds to GBWDB through the Administrative Entity, as set forth in section (I) (D).
