PURPOSE:

To transmit to Local Areas Performance Standards for PY 2014

REFERENCE:

Workforce Investment Act of 1998, Section 136; WIA Regulations at 20 CFR

Part 666.300 and Part 666.310; and TEGL 25-13.

SUBSTANCE:

On June 13, 2014, the Commissioner of Labor on behalf of the Governor negotiated with Employment and Training Administration Regional Office for PY 2014 WIA Title IB and Wagner-Peyser program goals. The State is required to negotiate standards with the local areas to be used as a basis for evaluating program performance, making incentive/technical assistance awards, or imposing sanctions. The levels must be based on the State negotiated levels of performance.

Due to the increase in several statewide performance measures, the Nebraska Department of Labor (NDOL) assessed and proposed revisions to five of the nine common measures for each of Nebraska's three local areas. On July 9, 2014, these proposed performance measure increases were sent to each local area, with a scheduled negotiation session set for July 29, 2014 for any local area wishing to further discuss or modify the proposed increases for their local area. All three local areas notified NDOL of their intention to accept the proposed performance measure increases.

and as such the July 29, 2014 meeting was cancelled.
