APPROVAL OF MINUTES:

Lisa Wilson motioned to approve the minutes for the September 7, 2017 Executive Committee meeting. Chris Callihan made the motion and Roy Lamb seconded. All members present voted by a voice vote to approve the motion, which carried unanimously.

NEW BUSINESS:

Review and Approval of the Columbus Regional Plan

Dylan Wren, Program Coordinator, gave an overview of the Columbus Regional Plan.

Lisa Wilson motioned for the Executive Committee to approve the Columbus Regional Plan. Roy Lamb made the motion and Chris Callihan seconded the motion. All Executive Committee members present voted by a roll call vote to approve the motion, which carried unanimously.

Review and Approval of the Norfolk Regional Plan

Dylan Wren gave an overview of the Norfolk Regional Plan.

Lisa Wilson motioned for the Executive Committee to approve the Madison Norfolk Regional Plan. Denise Pfeifer made the motion and Roy Lamb seconded the motion. All Executive Committee members present voted by a roll call vote to approve the motion, which carried unanimously.

Annual Funding Agreement

The committee and partners present at the Executive Committee Meeting on September 7th requested that all partners review their customer served numbers to assure uniformity with the customer served definition by the close of business on Monday, September 11.

The committee also requested information from the partners in regards to FTE's. The committee did not move forward with collecting this information as it has proven to be difficult for partners to calculate (i.e. an FTE may be stationed in Beatrice but may also provide services in Lincoln). Additionally, at the joint local workforce development area meeting with partners, the FTE method was unpopular and was only collected as a means to create a blended calculation. Both Omaha and Lincoln Workforce Development Boards have tossed out the FTE method.

Dylan Wren provided an overview of the proposed motion.

Lisa Wilson motioned for the Executive Committee to approve the annual funding agreement with the amended effective date of October 1st, 2017. Roy Lamb made the motion and Chris Callihan seconded the motion. All Executive Committee members present voted by a roll call vote to approve the motion, which carried unanimously.
