
Background: Under the Workforce Investment Act, an Executive Committee was designated for the Greater Nebraska Workforce Investment Board to have authority to act on behalf of the full board between scheduled meetings.

It is proposed that an Executive Committee be established under the Workforce Innovation and Opportunity Act for the Greater Nebraska Workforce Development Board. This committee would have authority to act on behalf of the full board between scheduled meetings. The membership of this board would consist of the following board members:

- Board Chair
- Vice Chair
- Committee Chairs (expected to be a total of 2)
- At least one Workforce/Labor Representative
- At least one Economic Development or Government Representative
- Additional board members necessary for a total of 9 total Executive Committee Members

The majority of the Executive Committee Membership must be from the private sector.
